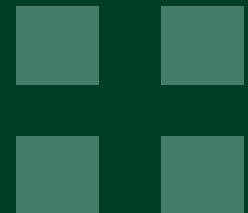

## MAKE A CONTRIBUTION

Contributions to the Kimball Medical Center Foundation may be tax deductible and may offer other favorable tax benefits.

### Gifts of Cash.

Contributions in the form of cash, check or credit card may be deducted from the donor's taxes in the year the gift is made. If the amount of the gift exceeds 50% of the donor's adjusted gross income, the excess may be carried over for up to five additional years until the full value is deducted. You also may specify which hospital area or project should receive your gift.
